## IMPORTANT INFORMATION

<p>- A tourist visa must be used within 60 days from the date it is granted, is valid for one or two entries, and enables its holder to remain in the country for up to 30 days, which may be extended once for the same period.</p> <p>- The Government may establish and update, unilaterally or by agreement, a list of countries whose citizens are exempt from entry visas for stays less than 90 days.</p> <p>- A tourist visa does not enable its holder to establish residency in the national territory or to engage in any remunerated activity.</p> <hr/> <p>Nos. 2, 3 and 5, Article 44 of Law 2/07 of August 31</p>	<p>- A transit visa must be used within 60 days from the date it is granted, authorizes a stay of up to 5 days, and is valid for one or two entries and may not be extended.</p> <p>- A transit visa may be granted on an exceptional basis at the border post to a foreign citizen who, in a continuous trip, interrupts it for the obligatory stops of the means of transport used.</p> <hr/> <p>Nos. 2 and 3, Article 43 of Law 2/07 of August</p>
<p>- A short-term visa should be used within 72 hours, and enables a foreign citizen to stay in the national territory up to 7 days, which may be extended for a like period.</p> <p>- Granting a short-term visa does not require prior authorization from the Service of Migration and Foreigners; it suffices to communicate that it has been granted.</p> <p>- A short-term visa does not enable its holder to establish residency in the national territory or to engage in any remunerated activity.</p> <hr/> <p>Nos. 2, 3 and 4, Article 45 of Law 2/07 of August 31</p>	<p>- A regular visa must be used within 60 days of the date on which it is granted, and enables its holder to stay up to 30 days, and may be extended twice, for like periods.</p> <p>- A regular visa does not allow its holder to establish residency in the national territory or to engage in any remunerated activity.</p> <hr/> <p>Nos. 2 and 3, Article 46 of Law 2/07 of August 31</p>
